COTFA Assistance Levels

Minimal On-Site Assistance:

- Determined by negotiation, but most responsibilities for planning and running the contest are left to the contest organizers. Contest is sanctioned, but not actively produced, by COTFA.

Substantial On-Site Assistance – COTFA Provides:

- Master copies of Rules, Entry Forms, Judging Forms and Tally Sheets for contest organizers to duplicate.
- Publicity on the COTFA website and newsletter.
- Hiring of Judges and Master of Ceremonies (contest pays the fees for these people.)
- COTFA volunteers to help run contest, including registration fee handling; runners for judges, warm-up area, master of ceremonies; design of posters if wanted and posting of contest posters at other contests.
